# PANHANDLE GROUNDWATER CONSERVATION DISTRICT BOARD OF DIRECTOR'S REGULAR MEETING MINUTES

President Thompson called the Regular Meeting to order at 9:41 a.m.

No Public Comment

1. CONSIDERATION AND POSSIBLE ACTION ON MINUTES FROM OCTOBER 26, 2021

Bill Breeding made the motion to approve the minutes from October 26, 2021, seconded by Charles Bowers. Motion passes unanimously.

- 2. CONSIDERATION AND POSSIBLE ACTION ON EXPENDITURES
  - a) October 2021
  - b) November 2021

John R. Spearman made the motion to approve the October 2021 expenditures, seconded by Bill Breeding. Motion passed unanimously.

Lee Peterson made the motion to approve the November 2021 expenditures, seconded by Danny Hardcastle. Motion passed unanimously.

3. CONSIDERATION AND POSSIBLE ACTION ON METER REPAIR ISSUE FOR METER NUMBER 8101581

Guest, Lance Williams, explained that one of his underground pipes burst and he thinks it is due to our Field Technician closing a valve and not opening it back up. Director, Danny Hardcastle, asked Williams what the cost to fix the pipe is. Williams said it will be around \$6,000.00 in parts and \$3,000.00 in labor. Field

Technician who performed the repair said he had no recollection of turning the valve off or not, however, it is something he does from time-to-time when performing repairs. Director Lee Peterson said it would have been helpful for Mr. Williams to take pictures or call the District before repairs started, that way we could have evaluated the situation. Director Bowers noted he had underground pipe burst before, and there could have been other factors at play here, and there was no way to know completely if the District caused the issue or not.

Danny Hardcastle motioned that the District pay for the damages when we receive the final invoice, seconded by Chancy Cruse. Motion passed unanimously.

# 4. CONSIDERATION AND POSSIBLE ACTION ON AMENDMENTS DISTRICT METER STANDARDS

President Thompson requested that field technicians have a checklist and take pictures of every step they take when doing any repairs. Director Breeding suggested we add a release form that landowners will sign after any meter repairs are done and directed Britten to work on that for next meeting.

Bill Breeding motioned to table the amendment meter standards and let the staff work on it until the next Board meeting, seconded by Charles Bowers. Motion passed unanimously.

## 5. CONSIDERATION AND POSSIBLE ACTION ON AG LOANS

- a. Steve Hightower Family Farms, LLC requested a loan amount of \$94,220 with a 1.08% interest rate over an 8-year span.
  - i. John R. Spearman motioned to approve the Ag Loan for Steve Hightower Family Farms, LLC, seconded by Bill Breeding. Motion passed unanimously.
- b. Mark & Sheri Urbancyzk requested a loan amount of \$150,000 with a 1.08% interest rate over an 8-year span for an irrigation system.
  - i. Danny Hardcastle motioned to approve the Ag Loan for Mark & Sheri Urbancyzk, seconded by Lee Peterson. Motion passed unanimously
- c. David Biggs requested a loan amount of \$150,000 with a 1.08% interest rate over an 8-year span for a Zimmatic Sprinkler.
  - i. Charles Bowers motioned to approve the Ag Loan for David Biggs, seconded by Bill Breeding. Motion passed unanimously.

## 6. CONSENT AGENDA- DRILLING PERMITS

The following items are a part of the Consent Agenda. All Well Permit requests have been thoroughly reviewed by the staff, are administratively complete and the Assistant General Manager and Permitting Administrator is recommending issuance.

### **RECLASSIFY WELLS** -

- 1. Friemel Family Farms requests to reclassify irrigation well #661150 located in the NE4 of Section 212, Blk B-4, H&GN Survey in Armstrong Co. from an 8" to a 4" well.
- 2. Friemel Family Farms requests to reclassify well #661253 located in the SE4 of Section 189, Blk B-4, H&GN Survey in Armstrong Co. from an 8" to a 4" well.

Britten stated we did flow test these and they are both fall within the correct gallons per minute for the reclassification.

Bill Breeding made the motion to reclassify both wells, seconded by Danny Hardcastle. Motion passed unanimously.

- e) Austin Bamert An 8" well to be drilled on 1792 acres by Lichtie Drilling by 12.1.21 in the NE4 of Sec 87 Blk 2, TT RR Survey (being located approx. 4 mi N on Panhandle on Hwy 207 to the intersection of CR 16 & Hwy 207, then approx. 1 mi W on CR 16, W side of Hwy 207, S side of CR 16)

Charles Bowers motioned to approve items a & b, seconded by John R. Spearman. Motion passed unanimously.

Danny Hardcastle motioned to approve items c, d & e, seconded by Charles Bowers. Motion passed unanimously.

7. CONSIDERATION AND POSSIBLE ACTION ON THE DISTRICT'S BOUNDARY ISSUE WITH HPWD

Britten told the Board that the District has sent all letters to effected landowners, and attorneys have yet to receive any waivers. Bowers suggested it may be beneficial to send out a joint letter with HPWD stating that if we don't get a response by February 1<sup>st</sup>, it will be considered that you, as the landowner, agree with the boundary in place.

Lee Peterson made the motion to send out a joint letter with HPWD to all effected landowners, seconded by Bill Breeding. Motion passed unanimously.

8. CONSIDERATION AND POSSIBLE ACTION ON DISTRICT IRS DEPLETION PROGRAM

Britten stated we hire a land appraiser, Gary Sutherland to go out and do a cost of water analysis. Gary has raised some concerns that more people are keeping land sales private thus making it hard for him to get values and do an appropriate analysis. He is requesting the Board help in getting said values. Gary stated they look at dryland sales and anything that is not irrigated. They also evaluate the irrigated land sales, noting they do take off the value associated with pivots, motors, etc. District Hydrogeologist, Ashely Ausbrooks, explained the process of creating the saturated thickness maps to the Board. The way making that map works is by taking data from last year and creating a contour map, then subtract those contours from the previous years to get the 1-year change in feet. Landowners must have water-developed land in order to participate in the program.

Bill Breeding made the motion to continue the IRS Depletion Program, seconded by Lee Peterson. Motion passed unanimously.

Britten announced Katie Hodges as Office Manager for the District.
