#### 1. CALL MEETING TO ORDER

President Thompson called the Regular Meeting to order at 9:06 a.m.

#### 2. PUBLIC COMMENT

# 5. CONSIDERATION AND POSSIBLE ACTION ON DATABASE CONTRACT WITH HALFF

Britten introduced Conrad Harrison, Service Team Leader for Halff. Conrad went through the Groundwater Management System (GMS) and explained what all it entails and how it will be beneficial for the District. Conrad stated the software will be tailored specifically to the needs of PGCD.

Bill Breeding made the motion to accept the quote and enter in the contract with Halff, seconded by Charles Bowers. Motion passes unanimously.

### 6. CONSIDERATION AND POSSIBLE ACTION ON RULES COMMITTEE REPORT

Britten stated the District called a Rules Committee Meeting due to the issue with the usage reports. Director Bowers gave the committee report noting the recommendation of having operators use energy consumption as an alternative metering method, in the event their first metering method fails for a significant period of time.

# 7. CONSIDERATION AND POSSIBLE ACTION ON DISTRICT METER STANDARDS

Britten stated based on conversations and recommendations from the Rules Committee, the District Meter Standards were amended to include the alternative usage method. Britten also stated the District has had issues with constituents not reporting when changes were made to their RMS or AgSense accounts. When this happens, it completely changes the past data.

Charles Bowers made the motion to amend the District Meter Standards to include the alternative usage method and include Operators must sign liability waivers prior to any meter installation, seconded by Danny Hardcastle. Motion passes unanimously.
