## PGCD HOSTS 6TH BIENNIAL WATER CONSERVATION SYMPOSIUM

Panhandle Groundwater Conservation District (PGCD), along with 23 sponsors, hosted the 6th Biennial Water Conservation Symposium on February 16, 2022. It was a beautiful day with a high number of attendees.

The District hosted 16 speakers from all over the state of Texas and one speaker from Maryland. A pertinent topic of the day was Rural Land Trends, which featured Dr. Roel Lopez, Director of Texas A&M Natural Resources Institute and Dr. Robert Mace, Executive Director of Meadows Center for Water & the Environment. Lopez and Mace explained the current rural land trends and the impact they have on groundwater and will continue to have in the future.

More presentations included: Brooke Paup, Chairwoman of the Texas Water Development Board, who gave an update on the 2022 State Water Plan. Randall County Master Gardner, Roger Gloe, informed attendees of efficient irrigation practices for lawns and gardens. Floyd Hartman, Assistant City Manager and Jonathan Gresham, Director of Utilities with the City of Amarillo explained the benefits of Amarillo's Smart Meter Technology. In addition to the speaker sessions, 14 of the 23 sponsors had booths with special giveaways and provided networking and educational opportunities for the attendees.

### DISTRICT METERING UPDATES

The Panhandle Groundwater Conservation District's Board of Director's amended the District Meter Standards on March 24, 2022. Directors decided Operators are required to sign liability waivers prior to any meter installation. If a flow meter is no longer operating in accordance with the flow meter manufacturer's specification, operators will need to notify the District within three business days. District Field Technicians can perform installations, repairs and routine maintenance after the District has received the signed meter waiver. If operators choose not to sign the waiver, then all installations, repairs and maintenance will be their responsibility. Directors decided in the event of a meter failure (whether a traditional flow meter or remote monitoring system), operators will use their energy consumption (natural gas or electric) to calculate total usage. This method may only be used as an alternative if the first metering method is nonoperational. For more detailed information on the alternative method that was adopted, please review the District Meter Standards at www.pgcd.us/metering.

Please see important meter reminders below:

- Start of season texts must include a clear view of the meter face while pumping and also must include the identifying sticker or the serial number plate which identifies your meter to the District. The purpose of this picture is not to obtain reading, but rather to see that your meter is operational. If your identifying sticker needs to be replaced, please contact the District. Texts can be sent to 806-883-2124.
- If an owner/operator replaces or adds a meter, the District must be notified so we can take the necessary steps to add the correct meter to the system. This also applies to any additional pivots added through RMS (PivoTrac, AgSense, FieldNET, etc.) so your use can be monitored.
